Executive Summary

The Judicial Council has statutory authority to allocate funding from statewide special funds for projects and programs that support the trial courts. This report contains staff recommendations to allocate \$7.4 million to courts for the replacement of personal computers and printers, but also authorize courts to redirect their allocation funds to mitigate the impact of budget reductions, as deemed necessary by each court, in fiscal year (FY) 2011–2012.

Recommendation

1. The Administrative Office of the Courts (AOC) recommends that, for FY 2011–2012, the council allocate \$7.4 million to courts for the replacement of personal computers and printers, but also authorize courts to redirect these funds to mitigate the impact of budget reductions, as deemed necessary by each court, in FY 2011–2012.

Previous council action

In FY 2000–2001, the Legislature appropriated \$7.4 million to the TCTF to partly address ongoing trial court funding needs for technology equipment replacement and software licensing upgrades. At its August 24, 2000, business meeting, the council allocated \$7.4 million from the TCTF to courts for the purpose of replacing personal computers and printers on a three-year cycle. Since FY 2000–2001 courts have received an annual statewide allocation of \$7.4 million from the TCTF for technology asset replacement, although in FY 2001–2002 and FY 2002–2003 the allocation was from the Improvement Fund and Modernization Fund as a result of allocated reductions of the \$7.4 million from the TCTF included in the State Budget in those years. In FY 2002–2003 and FY 2009–2010, courts were permitted to redirect their technology asset replacement allocations to mitigate the impact of budget reductions in those fiscal years.

Rationale for recommendation

Given the \$138.3 million statewide reduction in funding for trial court operations in FY 2011–2012, removing the restriction on the use of the personal computer and printer replacement allocations will provide courts the flexibility to redirect these funds toward more critical needs. The recommended action does not prevent courts from utilizing these funds to replace some of their technology assets. It is the opinion of AOC's Information Services Division that courts that choose to redirect their funds this fiscal year will face minimal risks with respect to personal computer and printer failures.

Comments, alternatives considered, and policy implications

Staff considered requiring courts to use the technology asset replacement funds for replacing personal computers and printer equipment. Courts that choose to redirect their funding could face the risk that some of their computers and printers will fail.
