## Commenting on behalf of an organization

#### General Comment:

The Strategic Evaluation Committee (SEC) was appointed by the Chief Justice to assess the priorities of the Judicial Council and to determine what changes might be made to improve the operational effectiveness and efficiency of the Administrative Office of the Courts (AOC).

We now have the SEC's comprehensive report which confirms the widespread view of judges and non-judges throughout the state - reforms at the AOC are needed. The recommendations/solutions within the report are entirely reasonable in light of the findings of the SEC and in view of our branch's severe budgetary reductions.

Interestingly, an observation made by the SEC report that, "... the Judicial Council has not been shown at the top of any AOC organization charts provided...", has apparently caused a change. I note that a July 2012 organization chart now available on the AOC website displays the Judicial Council above the AOC.

I think it imperative that the branch act upon the recommendations of the SEC. We can be certain that the legislature is watching whether we follow through with solutions within a report which was authored by a committee that the judicial branch itself sponsored. We now have a chance to control the types of changes that the SEC report finds necessary.
