Order Setting Practices Advisory Committee

 DCSS formed an Advisory Committee to make recommendations to the Directorate on pleading child support in an initial complaint.

• Objective: consistent, uniform services throughout California

 DCSS previously said that it would consider policy and regulatory changes as appropriate.

• Consistent, uniform statewide practices

Consider circumstances of customers

Follow the law when clear

Make recommendations if committee felt existing law is ambiguous

Guidelines & Goals Continued...

Collectability of an order should not determine pleading practices

• The law should be followed even if we believe the order is unreasonably high or low

• Counties have different resources, demographics, procedures

Consensus may not be possible

 Visitation/Timeshare 8 total recommendations

Timeshare Recommendations

 Timeshare is a percentage representing a parent's respective period of primary physical "responsibility" for the child.

• If the amount of timeshare is unknown, the LCSA should use 0% in the calculation.

• Aid status is irrelevant in determining timeshare.

• Telephone contact \neq timeshare

Presumed Income
9 total recommendations

Presumed Income Recommendations

If a support obligor's income or income history is unknown, child support is to be based upon presumed income.

Presumed income is minimum wage, at 40 hours per week.

• The amount of presumed income does not change in any county based upon local demographics. It is not higher or lower based upon a particular county's circumstances, such as a county that has a higher minimum wage than the state.

Presumed Income Recommendations

Presumed income should not be used for the CP.
 CSE should track presumed income orders to

determine whether the orders are effective.

 CSE should be enhanced via a modification to task FM003 which currently generates when an initial payment is received via IWO only (expand for all payment sources)

The amount of presumed income orders should be lowered. Legislation will be required to effect this change.

Imputation Recommendations

• The Committee could find no current legal authority for a LCSA to impute income in an initial pleading.

• The Committee recommends that LCSAs be given statutory authority to impute income.

Zero Order Recommendations

A zero order is appropriate if the NP's only income is SSI or TANF; if the NP is incarcerated for more than 90 days, institutionalized in a psychiatric facility, or has a medically verified total and permanent disability.

• A zero order should not be obtained when there is no income information.

 A zero order should not be obtained based on a NP's undocumented status.

Best Practice Recommendations

• As best practices for the handling of every case, the Committee recommends LCSAs need to make a diligent attempt to contact parties on the case to gather information.

As best practices for the handling of every case, the Committee recommends that as a part of the early intervention activities, LCSAs should work collaboratively with its customers, attempt to educate parents on the importance of support factors, and work with customers to achieve agreements (stipulations).

Best Practice Recommendations

 As best practices for the handling of every case, the Committee recommends LCSAs should inform NPs of their right to file an answer and to appear in court if there is a dispute over income, timeshare, etc. As best practices for the handling of every case, the

Committee recommends LCSAs should encourage the CP to appear in court if the NP files an Answer.
