# **POP Copies**

• LCSA can now view POP image and print for participant

 Certified copy obtained from DCSS

#### State License Match System

Family Code § 17520

 Non-Compliance = >30 days in arrears

 "Delinquency" is different – FC 17500(c), 60 days past due, aggregate >\$100

## **SLMS Matches**

Driver's License

 Professional License: Law, Contractor, other Business, Commercial motor vehicle, Commercial fishing license, Notary Public, etc.

# **SLMS Process**

- Board serves notice to Obligor on Certified List to last known address
- Temporary license = 150 days
- Notice again at 30 days for DL

#### **SLMS Court Review**

- Request for Judicial Review, FL-670
  - Defenses In compliance, mistaken identity, no order, Other
  - Hearing within 20 cal days

## SB 85 Amnesty

- Commencing July 1, 2015: Counties must establish program
  - Fines and bail initially due before 1/1/2013. Accept \$ between 3/1/2015-3/31/2017

# SB 85 and DCSS

 No direct link as IV-D
 Commissioners do not hear these requests in IV-D court

 However, good to be aware.
 Educate others; amnesty does not affect child support hold

#### **Innovative Court Practices**

- Rules of Court, Rule 5.125 on submission of OAH
  - Important to get Order filed as soon as possible to get \$\$ to families in need

LCSA personnel in court to help

## **Video Conference**

- Placer uses video conferencing to assist
- LCSA personnel connected by video prepare orders which print in courthouse
- Reviewed, filed, served

# **In Person Option**

• Tulare utilizes personnel in court, next to court clerk

 LCSA personnel prepare order and print on LCSA equipment

Reviewed, filed, served

## **E-Filing**

E-filing is the process of sending and receiving legal documents electronically from the local child support agency (LCSA) to the county court via batch process in order to expedite case processing

- Implementation


