The Judicial Council has submitted a report to the Legislature in accordance with the 2006 Budget Act (Stats. 2006, ch. 47/48) and the 2007 Budget Act (Stats. 2007, ch. 171).

The following summary of the report is provided under the requirements of Government Code section 9795.

The Budget Acts of 2006 and 2007 (provisions 10 and 11, respectively) provided funding for new trial court judgeships, supporting staff, and operations costs. The Budget Acts also required reports on the allocation of these funds for the new positions. The attached report provides information on the funding received in support of the judgeships and the amount allocated to each trial court in FY 2007–2008 and FY 2008–2009.

Report on Allocation of Funding for Support of New Judgeships Authorized in FY 2006–2007 and FY 2007–2008

I. Judgeships Authorized in FY 2006–2007

Background

The Budget Act of 2006 (Stats. 2006, ch. 47/48) provided funding beginning in fiscal year (FY) 2006–2007 for the costs to support 50 new trial court judgeships and staff. Allocation of the funding was contingent upon the passage of legislation authorizing the establishment of the judicial positions. The authorizing legislation, Senate Bill 56 (Stats. 2006, ch. 390), was enacted into law on September 22, 2006. Item 0250-101-0932, Provision 10 of the Budget Act of 2006 required that “the Judicial Council . . . report to the Legislature on January 1, 2008, and annually thereafter, until all judgeships are appointed and new staff hired,” on the funds allocated to each trial court to fund the new positions. This provisional language further required that any funds not used for the purpose of supporting the new judgeships revert to the state General Fund.

One month of funding for salaries and benefits and ongoing operational expenses and facilities funding was provided in FY 2006–2007. The allocation and reversion of these funds were reported in a previous report to the Legislature. The Budget Act of 2007 (Stats. 2007, ch. 171) contained a veto of one month of funding (\$2.980 million) for these judgeships, reducing the total amount appropriated in FY 2007–2008 to 11 months of funding. In FY 2008–2009, the final month of funding was appropriated. As of December 29, 2009, all 50 judgeships authorized and funded under SB 56 have been appointed. As a result of the completion of appointments, the report issued in 2011, covering fiscal year 2009–2010 funding, shall be the last report required under the language of the budget act.

Allocations

While only an additional 10 months of ongoing funding for these judgeships was appropriated in FY 2007–2008 (not including the one month already in the base funding), the Judicial Council approved allocation of the entire 12 months funding for support staff and operational expenses as many judges had been appointed and most courts had hired staff to support the judges.¹ The following table (see page 2) displays the allocations to the courts in FY 2007–2008 and FY 2008–2009 of the operational and support funding for the new judgeships and the ongoing facilities funding. (Allocation of the judicial compensation funding is not shown as this funding is not allocated to the courts.)

¹ Five judges were appointed in FY 2006–2007; 35 judges were appointed in FY 2007–2008; 9 judges were appointed in FY 2008–2009; and the final judge of the first complement of 50 judges was appointed in FY 2009–2010.

II. Judgeships Authorized in FY 2007–2008

Background

The Budget Act of 2007 (Stats. 2007, ch. 171) included \$27.767 million in FY 2007–2008 to support 50 new judgeships and staff. The funding represented one month of ongoing funding for the 50 judgeships, accompanying support staff, and facilities costs and the one-time funding associated with the positions and tenant improvements. Expenditure of the funding was contingent upon the passage of legislation authorizing the establishment of the judicial positions. The authorizing legislation, Assembly Bill 159 (Stats. 2007, ch. 722), was signed by the Governor and enacted into law on October 14, 2007. The funding provided assumed that judgeships could begin being appointed at the end of FY 2007–2008.

As part of a special legislative session addressing midyear budget issues, on February 15, 2008, the Senate and Assembly passed legislation that reduced funding to the Judicial Branch in FY 2007–2008 by delaying

the funding for the additional 50 judgeships (and the related staff and facility costs) authorized by AB 159 from June 2008 to June 2009.

Subsequent actions of the Legislature and Governor further deferred funding for the judgeships from June 2009, to July 1, 2009. Funding of \$7.651 million remained in the Budget Act of 2007— \$2.651 million in one-time operational funding and \$5.0 million for one-time tenant improvements related to the new judgeships.

Item 0250-101-0932, Provision 11 of the Budget Act requires that “the Judicial Council . . . report to the Legislature on January 1, 2008, and each January 1 thereafter, until all judgeships are appointed and new staff hired,” on the funds allocated to each trial court to fund the new judgeships created under AB 159. Provision 11 further required that any funds not used for this purpose revert to the state General Fund. The one-time operational support funding was distributed to the courts in November 2007. The trial courts that received the new judgeship funding were surveyed to verify the amount each court expended in support of its anticipated new judicial positions and support staff in FY 2007–2008. Based on the survey, the amount of funding to be reverted was determined. Of the \$2.651 million in one-time operational funding provided in the Budget Act for the fiscal year, \$2.279 million was expended and \$271,955 reverted to the state General Fund. Of the \$5.0 million in one-time tenant improvement funding, \$4.992 million was allocated in FY 2007–2008.

The amount of one-time operational and tenant improvement funding distributed to each court in FY 2007–2008 is displayed in the table below. In FY 2008–2009, one month of ongoing staff and operating funding in support of the AB 159 judgeships was appropriated to the Trial Court Trust Fund, and one month of ongoing facilities funding was appropriated to the Court Facilities Trust Fund. The allocation of these funds is also displayed below.
