Dear Governor Newsom:

The Judicial Council respectfully requests your signature on SB 389, which amends the Mental Health Services Act (MHSA) to authorize counties to use MHSA moneys to provide services to persons who are participating in a presentencing or postsentencing diversion program or who are on parole, probation, postrelease community supervision, or mandatory supervision.

The council supports SB 389 because it would expressly authorize counties to use MHSA funding for mental health services for diversion program participants, and individuals on parole, probation, post-release community supervision, or mandatory supervision. Oftentimes, defendants agree, as a condition of supervised release or participation in a diversion program, to participate in mental health treatment. Nonetheless, the lack of availability of mental health services for those individuals is a constant challenge for courts. Yet, the success of certain individuals participating in diversion programs or on supervised release depends on appropriate mental health treatment. The council believes that the potential additional funding for mental health services will help address the shortage of those services, which will, in turn, help reduce recidivism.
