Dear Senator Allen:

The Judicial Council regrets to inform you of its opposition to SB 632. This bill would prohibit a court, in an action brought pursuant to the California Environmental Quality Act (CEQA), from enjoining or staying "a project that is consistent with a vegetation treatment program for which a program environmental impact report has been certified by the State Board of Forestry and Fire Protection[.]" (Proposed Public Resources Code sec. 21168.12.)

It is important to note that the Judicial Council's concerns regarding SB 632 are limited solely to the court impacts of the legislation, and that the council is not expressing any views on CEQA generally or the underlying merits of the projects covered by the legislation, as those issues are outside the council's purview.

The significant limits on the forms of relief that a court may use in a CEQA action challenging the projects covered by this bill sets a dangerous precedent by interfering with the inherent authority of a judicial officer, which in turn raises a serious separation of powers question.
