Subject: Assembly Bill 1655 (Jones-Sawyer) – Request for Signature

Dear Governor Newsom:

The Judicial Council respectfully requests your signature on AB 1655, which adds June 19th, known as “Juneteenth,” to the list of California state holidays and requires that courts be closed in observance of this day as a judicial holiday.

Juneteenth has been celebrated on June 19th since 1866 to commemorate the end of slavery in the United States. The celebration began in Texas, but it has spread throughout the United States to not only commemorate the end of slavery but also be a day to honor the significant contributions of African Americans to our society.

Currently, 48 states, the federal government, and the District of Columbia recognize Juneteenth as a state holiday or observance. More recently, a number of private companies as well as several other states and local governments have established Juneteenth as a paid holiday. In 2020, Virginia and New York made Juneteenth a paid state holiday, and the states of Washington, Massachusetts, New Jersey, New York, Pennsylvania, Oregon, and Illinois followed suit in 2021. On June 17, 2021, President Biden signed legislation immediately making Juneteenth a federal holiday.
