Dear Assembly Member Stone:

The Judicial Council is the sponsor of Assembly Bill 2309, which authorizes the disposition of the West Los Angeles Courthouse located at 1633 Purdue Avenue in the City and County of Los Angeles.

AB 2309 provides the legislative authorization required in order to dispose of the courthouse at fair market value, and requires the net proceeds from the sale be deposited into the Court Facilities Trust Fund, established by Section 70352 of the Government Code, to fund the on-going maintenance and repair of existing court facilities.

To ensure the disposition takes place as soon as possible, the bill contains an urgency clause.

For these reasons, the Judicial Council is sponsoring AB 2309.

The Judicial Council is the sponsor of Assembly Bill 2309, which authorizes the disposition of the West Los Angeles Courthouse at 1633 Purdue Avenue and the Mental Health Courthouse at 1150 North San Fernando Road, both courthouses are located in the City and County of Los Angeles.

AB 2309 provides the legislative authorization required in order to dispose of the courthouses at fair market value, and requires the net proceeds from the sales be deposited into the Immediate and Critical Needs Account, established by Section 70371.5 of the Government Code, to fund judicial branch facilities projects.
