Dear Senator Portantino:

The Judicial Council is pleased to sponsor and support AB 2532, which addresses the value of an hour of community service when someone demonstrates to the satisfaction of the court that paying the total fine would pose a hardship. This bill would value the hourly rate for community service at double the statewide minimum wage, based on the schedule for an employer who employs 25 or fewer employees, as specified. The bill would authorize a court by local rule to *increase* the amount that is credited for each hour of community service performed.

Currently, each county or court determines the hourly rate for community service in its jurisdiction, resulting in different rates throughout the state. AB 2532 is needed to provide a uniform and equitable statewide minimum hourly rate for community service. This bill would promote access to justice and provide a dignified and standardized rate across California for individuals who would suffer hardship if they had to pay their fines and fees.

One thing AB 2532 does NOT do is change who is eligible for community service. Nor does the bill change how an individual demonstrates the need to perform community service to the court.

What we seek to do is ensure that, from Modoc to San Diego, everyone who performs community service in lieu of paying an infraction violation fine has the number of hours for community service calculated the same, fair and reasonable way.
