#### **Executive Summary**

In compliance with the requirements of the Budget Act of 2012, this informational report concerns all program and project expenditures made in the third quarter of fiscal year 2012–2013 appropriated from Item 0250–001–0932 of the Budget Act of 2012.

#### **Previous Council Action**

The Budget Act of 2012, specifically Provision 2 of Item 0250–001–0932, requires the Administrative Office of the Courts to provide a quarterly report on all expenditures from that item within 30 days of the end of each quarter. The first quarter report was provided to the Judicial Council as an informational item during its October 26, 2012 business meeting and the second quarter report during its February 26, 2013 business meeting.

The Administrative Office of the Courts (AOC) respectfully submits this quarterly report, as required by the Budget Act of 2012 (Assem. Bill 1497; Stats. 2012, ch. 29), concerning all third quarter expenditures made from Item 0250–001–0932.

In the third quarter of fiscal year (FY) 2012–2013, \$4,520,609 was expended from Item 0250–001–0932 of the Trial Court Trust Fund. The breakdown of those expenditures by program or project is as follows:

- \$2,231,588 for the Sargent Shriver Civil Representation project
- \$1,210,849 for CCMS V3 operations
- \$541,380 for California Courts Technology Center operations
- \$286,416 for Phoenix Financial and Human Resources services

- \$125,480 for the Equal Access Fund program
- \$119,079 for CCMS V2 operations

Expenditures of \$4,520,609 were made from Item 0250–001–0932 for Phoenix Financial and Human Resources services, CCMS V2 and V3 operations, the Equal Access Fund program, the Sargent Shriver Civil Representation project, California Courts Technology Center operations, and court-appointed counsel/juvenile dependency counsel collections support.
