

2. Title of the **Outsourced Payroll Services to the Superior Courts of California**

3. This Amendment becomes effective on: **January 1, 2017**

4. The maximum amount that the Judicial Council may pay Contractor under the Agreement (as amended) is unchanged: **\$400,000.08**.

5. The parties agree to amend the **Master Agreement No. TCMA 200201** as follows:
 - A. The purpose of this Amendment is to extend the term of the agreement.
 - B. PURSUANT TO THIS As set forth in the Amended and Restated Master Agreement No. TCMA 200201 attached hereto ("Master Agreement"), BETWEEN THE JUDICIAL COUNCIL AND THE CONTRACTOR:
 - C. The Contractor shall continue to provide Payroll Services to the Superior Courts of California, as further set forth in the Contract Documents.
 - D. The term of this Agreement shall be extended from December 31, 2016 to **June 30, 2017**.

6. Except as provided in this Amendment, all terms and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.
