1. All capitalized terms not defined in this amendment (the “Amendment”) have the meanings given to them in the Agreement referenced above. As set forth in the Agreement, the term “Contractor” refers to **Kennedy Van & Storage, Inc.**, and the term “Establishing Judicial Branch Entity” or “Establishing JBE” refers to the **Judicial Council of California**.

2. Title of the Agreement: **Master Agreement for the San Francisco Moving and Installation Services**

3. This Amendment becomes effective on **July 1, 2021**.

4. The parties agree to amend the Agreement as follows:
 - A. The purpose of this Amendment is to exercise the 2nd year option term, and to revise Appendix A, Section 2, Estimated Scheduled Move Dates for the JBE’s, Table 1.
 - B. Contractor will continue to perform Moving and Installation Services for the Judicial Council Sacramento office, as indicated in Appendix A, Section 2(2.1)(A)(B).
 - C. Appendix A, Services Revision No. 2, is hereby deleted in its entirety and replaced with Appendix A, Services, Revision No. 3, attached hereto and incorporated herewith.
 - D. As further set forth in Appendix B, Payment Provisions, the total amount the Judicial Council may pay the Contractor under the Agreement, as amended, is unchanged and remains the same.
 - E. The expiration date of the Agreement is hereby changed from **June 30, 2021** to **June 30, 2022**.

5. Except as provided in this Amendment, all terms and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.
