Amendment 2 to the Agreement for Government Banking Services

Between

Bank of America, N.A.

And

The Judicial Council of California,

Administrative Office of the Courts ("AOC")

This Amendment 2 to the Agreement for Government Banking Services, MA-200307 ("Master Agreement"), between the Judicial Council of California, Administrative Office of the Courts, a state governmental entity ("you," "your," or "AOC"), and Bank of America, N.A., a national banking association ("we," "us," "our," or "Bank of America") amends the Treasury Services Agreement, Exhibit B of the Master Agreement, with the attached Exhibit B-1 ("Payment and Invoice Processing Services") and Exhibit B-2 ("Commercial and Corporate Card and Commercial Prepaid Card Services"). The words and phrases not otherwise defined herein will have the same meanings ascribed to them in Exhibit B of the Master Agreement.

RECITALS AND ADDITIONAL AGREEMENTS

- A. Bank of America and AOC are parties to an Agreement for Government Services dated January 1, 2004 ("Government Banking Services Agreement").
- B. Among the services Bank of America will provide to AOC pursuant to the Government Services Agreement are the payment and invoice processing services more fully described and governed by Exhibit B-1.

The parties hereby agree to amend the TS Agreement as follows:

- 1. Incorporate the attached Exhibit B-1, Treasury Services Terms and Conditions, for the Payment and Invoice Processing Services, into the Master Agreement; and
- 2. Delete Exhibit H, Revision 1, in its entirety and replace it with the attached Exhibit H, Revision 2.
