

**Amendment No. 1 to
Master Agreement between the
Judicial Council of California
For the Benefit of the Superior Courts and Counties of the State of
California; and other governmental or regulatory entities
identified by the Judicial Council (the Participating Entities)
and
Pioneer Credit Recovery**

This Amendment is made by and between: Pioneer Credit Recovery, 14623 N.E. N. Woodinville Way, Suite 105, Woodinville, WA 98072, hereinafter referred to as "Contractor" and the Judicial Council of California, to modify the Master Agreement dated the 1st day of January, 2014 ("Master Agreement").

Pursuant to this Amendment No. 1 to Master Agreement No. MA-201310 between the Judicial Council and the Contractor:

DARFUR CONTRACTING ACT CERTIFICATION
