Re: Report of Electronic Recording Equipment Purchased or Leased by Superior Courts (July 1 through December 31, 2022), as required by Government Code section 69958

Dear Ms. Jenkins, Ms. Contreras, and Ms. Parker:

Pursuant to Government Code 69958, the Judicial Council is submitting the semiannual *Report of Electronic Recording Equipment Purchased or Leased by Superior Courts*, for the reporting period of July 1 through December 31, 2022. This report also includes supplemental information for the reporting period of January 1 through June 30, 2022.

From July 1 through December 31, 2022, seven courts reported a combined total of \$667,467 for the purchase of equipment or related items:

- Contra Costa Superior Court spent \$107,460 to purchase electronic recording equipment for use in limited civil and misdemeanor case types (see Attachment A).

- Los Angeles Superior Court spent \$451,889 to purchase electronic recording equipment for use in limited civil, infraction, and small claims case types (see Attachment B).
- Napa Superior Court spent \$5,850 to purchase electronic recording equipment for use in limited civil, misdemeanor, infraction, and small claims case types. Additionally, for use in performance monitoring, which is appropriate for all case types (see Attachment C).
- Orange Superior Court spent \$19,436 to purchase electronic recording equipment for misdemeanor and infraction case types. Additionally, for use in performance monitoring, which is appropriate for all case types (see Attachment D).
- Siskiyou Superior Court spent \$7,007 to purchase electronic recording equipment for use in misdemeanor case types (see Attachment E).
- San Mateo Superior Court spent \$35,464 to purchase electronic recording equipment for use in limited civil case types (see Attachment F).
- El Dorado Superior Court spent \$40,361 to purchase electronic recording equipment for use in limited civil case types (see Attachment G).

In addition to the items reported above, for the previous reporting period of January 1 through June 30, 2022, four courts reported a combined total of \$157,318 for the purchase or lease of electronic recording equipment or related items:

- Kern Superior Court spent \$1,990 to purchase electronic recording equipment for use in limited civil, misdemeanor, and infraction case types (see Attachment H).
- San Francisco Superior Court spent \$44,187 to purchase electronic recording equipment for use in limited civil case types (see Attachment I).
- Kings Superior Court spent \$9,693 to purchase electronic recording equipment for use in limited civil case types (see Attachment J).
- Contra Costa Superior Court spent \$101,448 to purchase and lease electronic recording equipment for use in limited civil and infraction case types (see Attachment K).
