Instructions For **GUARDIAN AD LITEM**

WHEN TO USE THIS PACKET

Use this packet if you are under 18 and have not been emancipated and are the parent of a child and you want to file paper work to establish paternity and/or to get orders for custody, visitation and support for your child.

STEPS IN PREPARING THE GUARDIAN AD LITEM:

The forms in this packet can be used if you are a minor and are the parent of child. If you are a minor you cannot represent yourself in a court action and need to have the court appoint you a Guardian Ad Litem. You can chose one of your parents or another adult to be your Guardian Ad Litem for the purpose of getting an order for custody, visitation and support of your child. This packet is completed along with a Petition to Establish



- 6 Fill in your name after I (name of the minor parent).
- Check the Box 1(a) and Box d. write in the minor parents date of birth, check the box to show who you live with, write in you mother's name and address and your father's name and address.
- 8 Fill in the name of the person who is applying to be the child's guardian. Include an address and phone number.
- Other person, explain the relationship (example: child's grandparent).
- Explain why a guardian for the child is needed ex. "I am a minor and cannot represent myself in court".
- If you need more space to write the reason why a guardian is needed, check this box. Attach additional pages and write Attachment 4 at the top of each page used.
