1.  **BY DEFAULT**

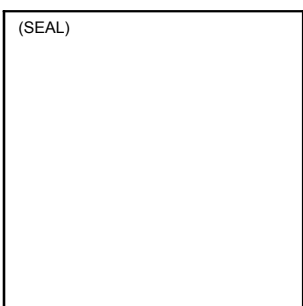
