SERVICE OF PROCESS ON THE SECRETARY OF STATE FOR NON-RESIDENT CORPORATIONS WITH NO AGENT FOR SERVICE OF PROCESS IN CALIFORNIA

Every corporation doing business in California is required to appoint an agent within the state to accept service of process. Some corporations fail to comply with this requirement and the only way to effect service is to apply for an order to allow service upon the California Secretary of State.

The procedure is as follows:

Fill out the Plaintiff's claim using the corporation's full name and address. Underneath the name and address write:

Serve: Secretary of State 1500 Eleventh St., Third Floor Sacramento, CA 95814-5701

Fill out the order completely (the portion above "COURT ORDER") and submit it to the Small Claims clerk to secure the signature of the Commissioner.

Once the order is signed, it must be sent to the Sacramento County Sheriff (or other private process server) to be personally served upon the California Secretary of State. The Sheriff charges \$60.00 dollars to do the service because they charge \$30.00 to serve each document (i.e. plaintiffs claim and the order). The Sheriff's Address is:

Be sure to send a short letter instructing the Sheriff to serve the Plaintiff's Claim and Order on the Secretary of State.

In addition to sending all of the above, a check in the amount of \$55.00 dollars payable to the "California Secretary of State" should be enclosed.

Once the California Secretary of State is served, it then serves the secretary of state in the state where the corporation is located. Then the Secretary of State in the other state notifies the corporation that they have been served.
