2. This Amendment No. 1 to Agreement MA-201604 becomes effective on: **September 1, 2018**.
3. The parties agree to amend the Master Agreement as follows:
 - A. The parties hereby agree to extend the Master Agreement beginning **September 1, 2018** and ending **August 31, 2019**.
 - B. The expiration date of the Master Agreement is hereby changed from **August 31, 2018** to **August 31, 2019**.
 - C. **Exhibit B-1 – Service Area Locations and Rates** is hereby replaced in its entirety with **Exhibit B-1 – Service Area Locations and Rates, Revision 1**, effective **September 1, 2018**, attached hereto and incorporated herein.
4. Except as provided in this Amendment, all terms and conditions of the Agreement, as previously amended, remain in full force and effect.
