Dear Mr. Navarette:

I am writing to identify the issues on which I expect to focus oral argument, calendared for September 5, 2018:

Argument VII: The trial court erroneously required the presentation of evidence regarding Mr. Gomez's refusal to come to court one morning, erroneously instructed the jurors that they could consider the refusal to come to court as evidence of a consciousness of guilt, and failed to perform the role of neutral arbiter; these errors violated Mr. Gomez's rights under California law and the state and federal constitutions.

In addition to appellant's opening and reply briefs, this issue is addressed in appellant's supplemental opening brief, filed April 6, 2015, and appellant's supplemental reply brief, filed June 5, 2015.

Argument XX: The prosecutor's elicitation, and the trial court's admission, over objection, of evidence regarding the ethnic background of two jail guards Mr. Gomez was charged with assaulting, evidence which the prosecutor then employed in arguing for death, requires reversal.

In addition to appellant's opening and reply briefs, this issue is addressed in appellant's second supplemental opening brief, filed May 16, 2017, and appellant's second supplemental reply brief, filed August 29, 2017.
