Dear Mr. Navarette:

In preparing for oral argument the following errors in appellant's opening brief came to my attention.

First, *People v. Vargas* (1975) 53 Cal.App.3d 516, 530, cited on page 189 of appellant's opening brief, did not involve an escape from custody; rather, it involved a defendant who was out of custody and failed to return on the second day of trial, and who was believed to have fled to Mexico. (*Id.* at 523.) The portion of *Vargas* cited and quoted by the trial court at 10RT 1605, however, discusses *People v. Terry* (1970) 2 Cal.3d 362, a case involving a defendant who had escaped from jail before trial. (*Vargas*, *supra*, 53 Cal.App.3d at p. 530.)

Second, the citations to *People v. Watson* in footnote 12, page 366, and at the bottom of page 367 are incorrect; the correct citation is 46 Cal.2d at p. 836.

In addition, I wish to clarify the first full paragraph on page 9 of appellant's opening brief: The multiple murder special circumstance applied to all the murder counts, not only to counts 10 and 11. (See 2CT 411.)
