We write to advise the Court that we expect our argument in this case will focus on the issues raised by opposing counsel in his respective focus letter, specifically:

Argument I in Appellant's Opening Brief: "Appellant's Fifth and Fourteenth Amendment rights were violated by the admission into evidence of statements appellant made after officers tricked him into waiving his *Miranda* rights, after he then twice invoked his right to counsel and after a process of "softening up" initiated by the officers during a car ride to the station following the second invocation."
