**Re: NOTIFICATION OF REDUCED SERVICE HOURS PURSUANT TO GC §68106**

Dear Judge Jahr:

Due to the severe budget cuts the judicial branch has experienced over the last several fiscal years, Tulare County has been forced to implement drastic cost saving measures, including the closure of the Tulare facility in August, 2012. As a result, the work from the Tulare Division has been redistributed to other divisions. The impact on the operations staff has been significant and we expect will be worsened by additional layoffs in the coming weeks. Due to the impact on staff, it has become necessary to reduce public phone hours to allow uninterrupted time to process the work.

Therefore, pursuant to Government Code section 68106, the Superior Court of Tulare County is hereby giving formal notice of our intent to reduce public phone hours in our Visalia and Porterville divisions effective November 1, 2013. Public phone hours will be 8:00 a.m. to 4:00 p.m. every day excluding weekends and holidays. Enclosed herewith for your information is a copy of the public notice to be posted at all locations.
