American Sign Language (ASL) Interpreters:

The Judicial Council requires ASL interpreters to hold the Specialist Certificate: Legal (SC:L), formerly issued by the Registry of Interpreters for the Deaf (RID) to be placed on the council's Master List of Certified Court and Registered Interpreters. If you do not have the SC:L certification from RID, we unfortunately cannot certify you as a California ASL court interpreter at this time.

The Court Interpreters Advisory Panel (CIAP), a standing advisory committee to the council, is exploring potential pathways to certifying new ASL interpreters in California. Please visit the CIAP webpage for additional information: https://www.courts.ca.gov/ciap.htm.
