THE OPPORTUNITY

You are invited to respond with information to assist the Judicial Council of California ("Judicial Council") in identifying roof consulting services and solutions for new construction and existing roof assemblies.

The Judicial Council of California, chaired by the Chief Justice of California, is the chief policy making agency of the California judicial system. The office of Real Estate and Facilities Management (REFM) of the Judicial Council is responsible for managing the state judiciary's portfolio. REFM manages the ongoing needs of more than 500 court judicial branch facilities, representing a 20 million square foot portfolio of court properties housing the largest judiciary in the United States, including operation, maintenance, repair, modifications, and environmental regulatory compliance, as well as site selection and acquisition for new capital projects.

The primary objective of this Request for Information ("RFI") is to gather information on qualified roof consulting services.

GENERAL REQUIREMENTS

The following are the primary considerations that should be addressed in this RFI:

- 1. Ability to provide comprehensive consulting, design, bidding, and project management support for roof systems at over 500 court judicial branch facilities, including, but not limited to
 - a. Visual roof inspections
 - b. Infrared and/or nuclear moisture surveys
 - c. Roof condition assessments with photographic documentation
 - d. Reports on system deficiencies & estimates on remaining service life
 - e. Cost estimates
 - f. Roof plan drawings and technical specifications
 - g. Energy & life cycle analysis
 - h. ACRM detection (asbestos testing)
 - i. Environmental sustainability
 - i. Roof design
 - k. New roof construction
 - 1. Roof repair
 - m. Roof replacement
 - n. Roof maintenance programs
 - o. Project management
 - p. Quality Assurance
 - q. Warranty and claims assistance
