Judicial Branch Statistical Information System (JBSIS) Data Quality Control and Amendment Guidelines (Action Required)

CEAC's JBSIS Subcommittee recommends adopting revisions to the JBSIS Manual that provides reporting standards and data definitions. Revisions include formatting of the manual and updates to definitions that were approved by the Judicial Council in January 2018. Additionally, the Subcommittee recommends that courts adopt data quality assurance protocols for JBSIS data reporting. Further, the Subcommittee recommends that specific guidelines be established to ensure that courts correct and amend JBSIS data errors. The latter items are in response to a request from the Judicial Council Advisory Committee for Audits and Financial Accountability for the Judicial Branch.
