OPEN MEETING

Call to Order and Roll Call

The chair called the meeting to order at 12:00 PM, introductions were made, and roll was taken.

DISCUSSION AND ACTION ITEMS

Item 1

Naming Request for the New Juvenile Courthouse in Murrieta

Mr. Chris Magnusson presented the request from the Superior Court of California, County of Riverside, indicating that there is a juvenile courthouse under construction in the City of Murrieta in the Southwest Justice Center. He stated that this new juvenile courthouse is a project the County of Riverside's Economic Development Agency is fully funding to replace superior court space in the former Indio County Administrative Building. He indicated that in 2013, the superior court had to vacate that county administrative building so the county could demolish the building to construct its East County Detention Center. He stated that this space-replacement project, which will be located adjacent to the juvenile hall in the Southwest Justice Center, will provide the superior court a new, two-courtroom juvenile courthouse for juvenile delinquency and dependency departments.

He noted that completion of this new juvenile courthouse is expected in summer 2017, and to have the requested name incorporated in the signage for the new courthouse, council staff must gain approval of the name at this time to assist the County of Riverside with its preparation of the signage design submittal for fabrication. He stated that the superior court's requested name for the new juvenile courthouse based on its location and case type meets the criteria (under section III.B.2.a) of the Judicial Council's *Courthouse Naming Policy* and recommended that owing to its precise compliance with the policy the committee make a recommendation to the Judicial Council for final action/approval.

Action: The subcommittee—with the exception of the members who were absent as shown above—voted unanimously on the following motion:

1. Recommend the Judicial Council approve the request to name the new juvenile courthouse, which is under construction in the Southwest Justice Center in the City of Murrieta, as the *Southwest Juvenile Courthouse, Superior Court of California, Riverside County.*

ADJOURNMENT

There being no further business, the meeting was adjourned at 12:30 PM.
