Subject: Senate Bill 567 (Bradford), as amended July 1, 2021 – Fiscal Impact Statement

Dear Assembly Member Gonzalez:

SB 567, which, among other things: (1) provides that when a judgment of imprisonment is to be imposed and the statute specifies three possible terms, the court shall, in its sound discretion, order imposition of a sentence not to exceed the middle term, unless there are circumstances in aggravation that, in the case of a trial by jury, have been stipulated to by the defendant, or, at trial by the jury or by the judge in a court trial, have been found true beyond a reasonable doubt, and (2) requires the court, upon the request of the defendant, to bifurcate the trial on the circumstances in aggravation from the trial of charges and enhancements. Provides that the jury shall not be informed of the bifurcated allegations until there has been a conviction of a felony offense.

Fiscal Impact

We estimate this bill could have a fiscal impact of approximately \$1.2 million annually, as a result of increased trial court workloads. The provisions of this bill create a significant workload impact on the courts by requiring that portions of the existing cases be bifurcated into two trials. Specifically, bifurcating these types of criminal matters will add between 150 minutes and 200 minutes of workload time to each case. We conservatively estimate that the provisions of this bill will annually impact 1,000 criminal case statewide. New unfunded workload to the courts could result in delays of court services, prioritization of court cases, and may impact access to justice.
