# Status of Product Acceptance and Discussion with Deloitte Regarding the Extension of the Warranty Period

AOC staff briefed the committee on the status of the CCMS product acceptance, the product warranty period, and the settlement of an outstanding credit from DeLoitte Consulting to be applied to the project. The committee discussed the timing of the warranty period and the deployment schedule projected for the early adopter courts and the need for a firm deployment schedule to resolve timing issues. The committee also discussed the responsibility for system maintenance over the warranty period.

#### Due Diligence

The committee chair expressed the expectation that the committee would stay informed of the due diligence process for assessing the recently proposed opportunity for a 3-way collaboration among the AOC, the State Bar of California, and the Chan Soon-Shiong Family Foundation for CCMS deployment. AOC staff summarized the planning and coordination underway within the AOC to conduct the due diligence process within the 12-week period pursuant to the letter of intent concerning the possible collaboration, which the Judicial Council on October 28, 2011, authorized the AOC to execute. The committee discussed the focus of due diligence and future communications to the branch on the progress of the due diligence effort.

#### **Developing Alternatives**

The committee chair noted the committee would be involved in the review of the deployment alternatives to be presented to the Judicial Council, at the conclusion of the due diligence period. The committee discussed cost considerations to include in the deployment alternatives and the need for a comparable cost basis for conducting financial analysis of each deployment alternative. The committee also discussed the possibility of collecting information from the State Bar on advantages of CCMS to practicing attorneys and their clients and including this information in the analysis of possible deployment solutions.

Future Internal Meeting Schedule

The committee agreed on establishing a conference call schedule at two week intervals for the duration of the due diligence period, through February 17, 2011.

#### WELCOME AND APPROVAL OF MINUTES

The meeting minutes from November 9, 2011 were approved.

#### CHAIR'S REPORT

Judge Herman, Chair of the CCMS Internal committee, welcomed Judge Richard J. Loftus, Jr. from Superior Court of Santa Clara County to the meeting. Judge Rosenberg, Chair of the Trial Court Presiding Judge Advisory Committee (TCPJAC), requested Judge Loftus, a vice-chair of TCPJAC, to attend and provide input on the due diligence process. There was a discussion regarding the deployment of CCMS in other courts after the early adopter courts and what the next steps would be.

Judge Herman stated that he and a steering committee of the CCMS Internal Committee, Justice Ashmann-Gerst, Judge Kaufman and Ms. Kim Turner, meet every Monday morning for an hour to keep abreast of developments. Judge Herman invited Mark Moore to provide information about product acceptance: the product acceptance document will be signed soon and Ron Overholt had a productive conversation with the vendor about a warranty extension.

#### **DUE DILIGENCE STATUS**

Judge Herman, Ms. Christine Patton, Ms. Mary M. Roberts, and Mr. Mark Moore provided an update on the status of the due diligence: the AOC and the State Bar have signed the letter of intent and the signature from the Chan Soon-Shiong Foundation is pending. Eight tracks will proceed under the due diligence effort: financial, governance, governmental affairs, legal, Program Management Office, communications, deployment, and technical.

#### **DEPLOYMENT ALTERNATIVES AND BUDGET**

Mark Moore briefed the committee on deployment alternatives and how the deployment budget could be reduced if there were collaboration with the Chan Soon-Shiong Foundation. Specific analysis will need to be performed to generate projected cost savings.

#### **LEGISLATIVE STATUS**

Mr. Curt Child, Director of the Office of Governmental Affairs, provided a legislative update. He has met with Senator Noreen Evans and budget staff in both houses. Senator Evans is displeased that general funds are not available for CCMS deployment. They were interested in knowing more about the due diligence process. He has been met with healthy skepticism, but no real criticism. They expect complete transparency throughout the process. He offered to keep them and the Bureau of State Audit (BSA) informed of the due diligence process.

- Naming the Judicial Council Conference Center which contains the Malcolm M. Lucas Board Room, on the third floor of the Ronald M. George State Office Complex, at 455 Golden Gate Avenue, San Francisco, in his honor, as the William C. Vickrey Judicial Council Conference Center; and
- The presentation of a Judicial Council resolution to Mr. Vickrey.

#### June 23 Judicial Council Working Draft Recommendations Meeting

The committee reviewed a June 23 working draft of recommendations from Judicial Council members on roles, responsibilities, and process in the following areas of council functions: oversight of the AOC, branch planning/communication/outreach, council meetings, and advisory groups. The committee considered short-, mid-, and long-term recommendations to the council in each area for enhancing governance procedures, expanding public participation in council proceedings, and opening council meetings. The E&P chair will report to the council and the public at the August 25, 2011, educational "issues" meeting on council initiatives in these areas. The committee recommends that the Judicial Council adopt these practices and approve the following:

# Judicial Council Oversight of the AOC

- 1. The Judicial Council requests its Advisory Committee on Financial Accountability and Efficiency for the Judicial Branch (A&E Committee) :
  - To undertake an analysis of the AOC budget by line item;

- To report to the council regarding AOC's current consultants and construction projects involving significant amounts of money; and
- To formulate a work plan and report to the Judicial Council, if possible at the October 2011 meeting, regarding its plan.

E&P will guide the A&E Committee in defining "significant" in connection with the second bullet. AOC is requested to include these elements in its development of a rule of court for the A&E committee.

- The Judicial Council requests that the Chief Justice appoint council members to act as liaisons to AOC divisions. E&P will oversee the development of recommendations to the Chief Justice for these appointments and clarify the purpose of these liaison assignments and the charge to the appointees. This liaison function may provide the basis for an educational topic at a future open Judicial Council meeting.
- 3. The Judicial Council looks forward to receiving information and recommendations from its Strategic Evaluation Committee (SEC) which is conducting an in-depth review of the AOC and its organizational structure to promote transparency, accountability, and efficiency in providing services to the courts.

# Branch Planning/Communication/Outreach

- 1. The Judicial Council, in June 2011, initiated the development of the next three-year operational plan for the judicial branch, slated for Judicial Council adoption in December 2012. Over the next 18 months, E&P, through services provided by the AOC, will actively seek the input of branch leaders in shaping and developing the next three year branch operational plan. E& P is committed to the development of an operational plan that reflects the fiscal times the branch faces and provides a roadmap for providing access to justice.
- 2. The Judicial Council requests the Trial Court Presiding Judges Advisory Committee to formalize a communications effort on behalf of the Judicial Council and the judicial branch with local bar associations concerning statewide judicial administration and the issues facing the branch. E&P will oversee development of this effort through the annual agenda process of the Trial Court Presiding Judges Advisory Committee.
- 3. The Judicial Council requests AOC staff to support council member efforts to inform the judicial branch, branch partners, and the public of issues that come before the council. Specific initiatives will include an open-meeting policy for educational meetings, more effective use of branch communication channels to the courts, council member participation in court site visits and at regional meetings, and enhanced media relations.
- 4. The Judicial Council requests AOC staff to support council member efforts in the Judicial Council's communication with the legislative and executive branches regarding branch issues.

# **Judicial Council Meetings**

- In order to make the council meetings more open and accessible, the Chief Justice has waived certain requirements in Rule 10.6(d) for requests to speak at council meetings. Speakers will be welcome to speak not only on items on the agenda, but also generally on matters affecting judicial administration. E&P has allocated a longer period of time at the beginning of the August 2011 meeting for general comments and before the presentation of each discussion agenda item. E&P has directed staff to accept requests to speak up to 2 days before the meeting.
- 2. E&P has set on the council agenda an open educational session, for Thursday, afternoon, August 25, and is planning open educational sessions for future issues meetings.
- 4. E&P, in its agenda setting, is allocating more time for council discussion to allow the council members greater opportunity for deliberation and consequently increased transparency of council decisionmaking.

- 5. E&P is taking charge of council meeting agenda setting and is directing that specific matters be placed on agendas and brought to the council, both informational matters and matters for decisions.
- 6. E&P has asked AOC staff to investigate methods for conducting council meetings by telephone or video, so long as the meetings remain open and accessible to the public.
- 7. E&P and AOC staff are making efforts to improve the timeliness of the delivery of meeting materials to the council members and to the public.
- 8. The 2012 Judicial Council meeting dates are being announced. Meetings in 2012 will be held during 8 months: January, February, April, June, July, August, October, and December. Having these more frequent meetings will allow E&P to set more open educational topics on agendas, as well as the ability to schedule sufficient time for the presentation and discussion of significant and consequential council decisions.
- 9. This budget year, the Judicial Council will not be able to convene in locations other than its home base, in order to keep expenses to an absolute minimum. When there is a more flexibility in the council's meeting budget, the members have expressed their interest in convening in at least one other location each year, similar to the Supreme Court outreach visits.

## Judicial Council Advisory Groups

1. The Judicial Council will review the structure and organization of its advisory groups, including its advisory committees and task forces, and their subcommittees and advisory groups. E&P may set this as a topic for an open educational Judicial Council meeting.
