


1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above (the "Agreement"). As set forth in the Agreement, the term "Contractor" refers to **Language Select, LLC** and the term "Judicial Council/Administrative Office of the Courts" or "State" refers to the **Judicial Council of California**.
2. This Amendment becomes effective on June 30, 2017. The parties agree to amend the Agreement as set forth below.
  - A. Language Select, LLC has been acquired by United Language Group, LLC and their legal name has been changed. All references to "Language Select, LLC" in the Agreement and previous amendments to the Agreement are hereby changed to **Language Select, LLC, dba United Language Group, LLC**.
  - B. Judicial Council of California elects to exercise the third and last option term for the period of July 1, 2017 through June 30, 2018. Therefore the term of this Agreement is extended through **June 30, 2018**.
