

4. The maximum amount that the Judicial Council may pay Contractor under the Agreement (as amended) is **\$0.00**

  - A. The purpose of this Amendment is to: i) exercise the first option to term; and ii) change the Contact information for the Judicial Council's Contract Manager and Project Manager.
  - B. Pursuant to Exhibit A, General Conditions, Paragraph 1, Terms, the Judicial Council hereby exercises its option to extend the Master Agreement for the First Option Term period beginning **July 1, 2015** and ending on **June 30, 2016**.
  - C. Exhibit A, General Conditions, Paragraph 22, Requests; Communication; Notice, is hereby deleted in its entirety and replaced with Exhibit A, General Conditions, Paragraph 22, Requests, Communication; Notice, attached hereto and incorporated herewith.
  - D. Contractor shall continue to provide Statewide Telephone Interpreter Services.
  - E. The expiration date of the Leveraged Purchasing Agreement is hereby changed from **June 30, 2015** to **June 30, 2016**.
