
1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above (the "Master Agreement"). As set forth in the Master Agreement, the term "Contractor" refers to **Cascade International Technologies, Inc.** and the term "Judicial Council" or "State" refers to the **Judicial Council of California**.
2. This Amendment becomes effective on: **November 1, 2016**.
3. The parties agree to amend the Master Agreement as follows:
  - a) Notwithstanding Exhibit C – Master Agreement Terms and Conditions, Section 1, Term, the Judicial Council and Contractor agree to extend the term of the Master Agreement through **October 31, 2017**. The expiration date of the Master Agreement is hereby changed from **October 31, 2016** to **October 31, 2017**.
  - b) All references to "AOC" and "Judicial Council of California, Administrative Office of the Courts" in the Master Agreement and previous Amendments are hereby changed to **Judicial Council of California**.
  - c) Exhibit C – Master Agreement Terms and Conditions, section 20, Requests/Communications/Notice, paragraphs (a) and (b) are hereby deleted in their entirety and replaced with the following:
    - (a) All requests, communications and notices concerning this Master Agreement must be made through the Judicial Council Contract Officer. Notice to the Judicial Council must be in writing and be delivered to the Judicial Council Contract Officer at the following address by depositing in the U.S. Mail or commercial express mail, first-class and pre-paid with return receipt requested:
