1. All capitalized terms not defined in this amendment (the "Amendment") have the meanings given to them in the Master Agreement referenced above (the "Agreement"). As set forth in the Agreement, the term "Contractor" refers to **California Service Bureau** and the term "Judicial Council/Administrative Office of the Courts" or "State" refers to the **Judicial Council of California**.

2. This Amendment becomes effective on December 31, 2016.

3. Contractor wishes to assign all of its rights and obligations under the Agreement to an affiliate, EOS CCA and the Judicial Council of California elects to exercise the second option term for the period of January 1, 2017 through December 31, 2017. As such, the parties agree to amend the Agreement as set forth below.

4. All references to "AOC", and the "Judicial Council/Administrative Office of the Courts" in the Agreement and previous amendments to the Agreement are hereby changed to Judicial Council of California.

5. The Judicial Council of California hereby exercises its option to extend the term of the Agreement through December 31, 2017.

8. This assignment and assumption agreement ("Assignment") is made as of **December 12, 2016** (the "**Assignment Date**") among **California Service Bureau**. ("Contractor"), **Judicial Council of California** ("Judicial Council") and **EOS CCA a wholly owned subsidiary of EOS Group** ("EOS CCA") regarding Master Agreement Number MA-201303 (the "Agreement").
  - A. **Assignment and Assumption.** Contractor hereby fully and forever assigns all of its rights, interests, duties and obligations in, to and under the Agreement to EOS CCA. EOS CCA, for good and valuable consideration, hereby accepts Contractor's assignment, and assumes and agrees to perform all the duties and obligations of Contractor arising under the Agreement from and after the Assignment Date. With respect to all rights and obligations arising from and after the Assignment Date, the term "Contractor" in the Agreement will refer to EOS CCA.
  - B. **Consent.** Judicial Council consents to the assignment and assumption of the Agreement from Contractor to EOS CCA pursuant to this Assignment and acknowledges that the Agreement will remain in full force and effect in accordance with its terms, as modified in this Assignment. This Assignment will apply to, bind, and inure to the benefit of the parties and their respective heirs, legal representatives, successors, and assigns, from and after the Assignment Date.
  - C. The parties agree that this Assignment represents the parties' entire understanding regarding its subject matter.

9. The parties agree that except as provided in this Amendment, all terms and conditions of the Agreement, as previously amended, remain in full force and effect.
