The request is denied. This court's decision in *Alvarado v. Dart Container Corp. of California* (S232607), filed on March 5, 2018, did not purport to change the governing California decisional law with respect to the effect to be given to provisions of the DLSE Enforcement Policies and Interpretation Manual. Furthermore, in the present case, this court has already requested and received supplemental briefing from the parties regarding the effect of the DLSE Manual on the issue presented in *Dynamex*. Dynamex has not made a sufficient showing that additional supplemental briefing on this issue is warranted at this late post-submission stage.
