The court orders that the voluntary resignation of JULIE A. KIRBY, State Bar Number 129152, as a member of the State Bar of California is accepted.

JULIE A. KIRBY must also comply with rule 9.20 of the California Rules of Court and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.
