Good cause appearing, and based upon counsel Randall Bookout's representation that the appellant's opening brief is anticipated to be filed by January 1, 2018, counsel's request for an extension of time in which to file that brief is granted to May 8, 2017. After that date, only four further extensions totaling about 240 additional days are contemplated.

An application to file an overlength brief must be served and filed no later than 60 days before the anticipated filing date. (See Cal. Rules of Court, rule 8.631(d)(1)(A)(ii) & (B)(ii).)

S239417**CHAVEZ ON DISCIPLINE**

Recommended discipline imposed

The court orders that FERNANDO FABELA CHAVEZ, State Bar Number 86902, is suspended from the practice of law in California for two years, execution of that period of suspension is stayed, and he is placed on probation for three years subject to the following conditions:

1. FERNANDO FABELA CHAVEZ is suspended from the practice of law for a minimum of the first year of probation, and he will remain suspended until the following conditions are satisfied:
 - i. He makes restitution to Noemi Barajas Arellano in the amount of \$23,500 plus 10 percent interest per year from December 6, 2010 (or reimburses the Client Security Fund, to the extent of any payment from the Fund to Noemi Barajas Arellano, in accordance with Business and Professions Code section 6140.5) and furnishes satisfactory proof to the State Bar's Office of Probation in Los Angeles; and
 - ii. If he remains suspended for two years or more as a result of not satisfying the preceding condition, he must also provide proof to the State Bar Court of his rehabilitation, fitness to practice and present learning and ability in the general law before his suspension will be terminated. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std. 1.2(c)(1).)
2. FERNANDO FABELA CHAVEZ must also comply with the other conditions of probation recommended by the Review Department of the State Bar Court in its Opinion filed on November 15, 2016.
3. At the expiration of the period of probation, if FERNANDO FABELA CHAVEZ has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

FERNANDO FABELA CHAVEZ must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order, or during the period of his suspension, whichever is longer and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).)

FERNANDO FABELA CHAVEZ must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
