Opinion filed: Affirmed in part, reversed in part

For the reasons above, we reverse the Court of Appeal's judgment affirming the true findings on the prior conviction allegation and the five-year sentence. In all other respects, we affirm the Court of Appeal's judgment, and we remand for further proceedings not inconsistent with this opinion.
