Order filed

Due to clerical error on the part of the State Bar of California. The order of this court filed May 10, 2018, suspending BYRON GRANT CORNELIUS, is hereby amended to read in its entirety:

"The court orders that BYRON GRANT CORNELIUS, State Bar Number 108248, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

1. BYRON GRANT CORNELIUS is suspended from the practice of law for the first 60 days of probation;
2. BYRON GRANT CORNELIUS must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on January 11, 2018; and
3. At the expiration of the period of probation, if BYRON GRANT CORNELIUS has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

BYRON GRANT CORNELIUS must also take and pass the Multistate Professional Responsibility Examination within one year after the effective date of this order and provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period. Failure to do so may result in suspension. (Cal. Rules of Court, rule 9.10(b).) Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. One-half of the costs must be paid with his membership fees for each of the years 2019 and 2020. If BYRON GRANT CORNELIUS fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

This order is entered nunc pro tunc as of May 10, 2018."
