Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

Recommended discipline imposed

The court orders that GERALD HOWARD STERNBERG, State Bar Number 96110, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

1. GERALD HOWARD STERNBERG is suspended from the practice of law for the first 60 days of probation;
2. GERALD HOWARD STERNBERG must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Order Approving Stipulation filed on July 11, 2018; and
3. At the expiration of the period of probation, if GERALD HOWARD STERNBERG has complied with all conditions of probation, the period of stayed suspension will be satisfied, and that suspension will be terminated.

JENNA M. MAACK must comply with California Rules of Court, rule 9.20 and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

Recommended discipline imposed

The court orders that ROBERT MICHAEL SALOMON, State Bar Number 194660, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for one year subject to the following conditions:

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. One-half of the costs must be paid with his membership fees for each of the years 2020 and 2021. If ROBERT MICHAEL SALOMON fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

Recommended discipline imposed: disbarred
