Recommended discipline imposed

The court orders that KEVIN ALAN BOVE, State Bar Number 149675, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and he is placed on probation for two years' subject to the following conditions:

1. KEVIN ALAN BOVE is suspended from the practice of law for the first 30 days of probation;
2. KEVIN ALAN BOVE must comply with the other conditions of probation recommended by the Hearing Department of the State Bar Court in its Decision filed on June 29, 2017; and
3. At the expiration of the period of probation, if KEVIN ALAN BOVE has complied with all conditions of probation, the period of stayed suspension will be satisfied and that suspension will be terminated.

If DERMOT DAMIAN GIVENS fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.
