Recommended discipline imposed

The court orders that ROBERTA ANN DiPRETE, State Bar Number 118940, is suspended from the practice of law in California for one year, execution of that period of suspension is stayed, and she is placed on probation for one year subject to the following conditions:

1. ROBERTA ANN DiPRETE is suspended from the practice of law for the first thirty days of probation;

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
