Recommended discipline imposed: disbarred

The court orders that PHILLIP GERRALD SAMOVAR, State Bar Number 39842, is disbarred from the practice of law in California and that his name is stricken from the roll of attorneys. PHILLIP GERRALD SAMOVAR must make restitution to Tawny L. McWilliams in the amount of \$315,000 plus 10 percent interest per year from March 1, 2013. Any restitution owed to the Client Security Fund is enforceable as provided in Business and Professions Code section 6140.5, subdivisions (c) and (d).
