#### **O**PEN MEETING

#### Call to Order and Roll Call

The chair called the meeting to order at 12:15 p.m., and staff took roll call.

#### **Approval of Minutes**

The Subcommittee reviewed and approved the minutes of the December 10, 2020, meeting.

#### INFORMATIONAL ITEMS (ITEMS 1-3)

#### Item 1: Update from Chair

Chair Justice Victor Rodriquez acknowledged Judge Erica Yew for her service to PAF and the Subcommittee. He welcomed two new PAF members who agreed to join the Subcommittee, Judge Richard Y. Lee from Orange Superior Court, and Ms. Fariba Soroosh, Supervising Attorney at Santa Clara Superior Court's Self-Help Center and Family Law Facilitator's Office. Justice Rodriguez shared that for the Fiscal Year (FY) 2021-22 budget, there are new, one-time monies of \$30 million to support hires of new court interpreter employees.

#### Item 2: Update on 2021 Language Access Projects

Douglas Denton, Principal Manager of Language Access Services, introduced new staff, Senior Analyst Eunice Lee, who will oversee the Video Remote Interpreting (VRI) Program.

Model Translation Guidelines for Courts: The Model Translation Guidelines is currently in

progress. Once completed, the guidelines will be shared with the subcommittee, PAF, and Language Access Representatives (LARs), and posted on the Language Access Toolkit.

**Support for Implementation of California Rules of Court, Rule 1.300**: Staff is working with the National Center for State Courts (NCSC) to develop findings and strategies to assist the courts and justice partners with implementation of California Rules of Court, Rule 1.300 (language assistance in court-ordered programs and services).

**Language Access Signage and Technology Grants**: For Cycle 3 grants (FY 2021-22), the draft recommendations were approved by PAF and the Information Technology Advisory Committee, and next go to Technology Committee for approval to submit to council in November 2021.

Language Access Annual Survey: Staff will develop the 2020 survey report in winter 2021.

**Public Outreach Campaign**: Translated ads and public service announcements ran in multilingual radio stations and print publications throughout the state in August-October 2021.

**Item 3: Review Potential 2022 Language Access Projects** Staff reviewed potential projects for inclusion in the 2022 PAF Annual Agenda:

1. **Update Bench Card on Working with Court Interpreters**: A 2017 bench card, previously developed under the Language Access Plan Implementation Task Force, will be updated to include guidance for bench officers on LEP waiver of a court interpreter and the appropriate use of technology when having remote proceedings that require language access.

2. Evaluate Strategies to Support Courts with Implementation of Rule 1.300: The Subcommittee and staff will evaluate the findings and potential strategies and considerations from NCSC.

3. Language Access Signage and Technology Grants: Staff will launch Cycle 4 (FY 2022-23) of the Signage and Technology Grants application in Spring 2022.

4. **Annual Language Access Survey**: Staff will administer the survey in Summer/Fall 2022 to determine courts' provision of language access services as of June 30, 2022.

5. Placeholder for Project(s) Assigned by the Ad Hoc Workgroup on Post Pandemic Initiatives: Staff shared the last project is a placeholder, in the event the PAF and/or Subcommittee is assigned a project by the Ad Hoc Workgroup on Post Pandemic Initiatives.

#### Committee's Charge/Membership:

<u>Rule 10.55</u> of the California Rules of Court states the charge of the Advisory Committee on Providing Access and Fairness (PAF), which is to make recommendations for improving access to the judicial system, fairness in the state courts, diversity in the judicial branch, and court services for self-represented parties. The committee also makes recommendations to the Center for Judicial Education and Research (CJER) Advisory Committee, proposals for the education and training of judicial officers and court staff.

<u>Rule 10.55(c)</u> sets forth the membership position of the committee. PAF has 30 members. The current committee <u>roster</u> is available on the committee's web page.

## Subcommittees/Working Groups<sup>2</sup>:

- 1. Judicial Diversity Toolkit Working Group: Review and consider ideas and recommendations in collaboration with members of the State Bar's Council on Access and Fairness (COAF) for future updates to design and content to the newly created *Pathways to Judicial Diversity* website; lead efforts on disseminating information statewide through collaboration with justice partners.
- 2. Standing Language Access Subcommittee: Advise and present recommendations to PAF regarding the Language Access Plan (LAP) and its overarching goal of ensuring access to justice for all court users, especially court users with limited English proficiency; as appropriate, make recommendations to PAF in the areas of technology, education, and translation; as well as recommendations on legislative and rule of court proposals to enhance language access services throughout the judicial branch.
- 3. Ad Hoc Legislative Working Group: Review and receive updates on legislation from the Judicial Council Governmental Affairs in the areas of access and fairness affecting the judicial branch.

This may include recommendations regarding plain language translation informational sheets, and other factors affecting the user-friendliness of forms that CLAC seeks to review.

PAF presented the Pathways to Judicial Diversity website and toolkit in person once and four times by videoconference throughout the state including to local courts, bar associations leaders, and to the Judicial Nominees Commission. PAF was able to reach a wider audience statewide by continuing virtual presentations due to COVID-19. Status: Presentations of toolkit will be ongoing in 2022.
2.	<b>Collaborate and Provide Subject Matter Expertise:</b> During the prolonged effects of the COVID-19, staff continued to provide training on the COVID-19 emergency rules related to unlawful detainers to Self-Help Centers statewide. Staff continued to update a statewide education and training website resource and convened weekly online trainings and updates during COVID-19 for Self-Help providers. Status: Ongoing.
3.	<b>Model Translation Guidelines for Courts:</b> PAF's Language Access Subcommittee is developing model translation guidelines for courts that provide guidance on the identification of vital documents for translation including local forms, local court web content, and other public-facing materials. The guidelines will be presented to PAF and posted to the Language Access Toolkit in Spring 2022. Status: Ongoing.
4.	<b>Support for Implementation of California Rules of Court, Rule 1.300:</b> PAF's Language Access Subcommittee consulted with NCSC to assist with implementation of California Rules of Court, rule 1.300. A report will be presented to PAF and posted to the Language Access Toolkit in Spring 2022 with recommendations and strategies for review and evaluation by the Language Access Subcommittee. Status: Ongoing.
5.	Language Access Signage and Technology Grants: In coordination with the Judicial Council Executive Office, PAF Language Access Subcommittee, ITAC, and Technology Committee, CFCC Language Access Services Program disbursed ongoing monies (\$2.35 million each year) for language access signage and technology grants, which are supported by the 2018 Budget Act. In November 2021, for Cycle 3 of the grant program (FY 2021–22), the council approved grants for 22 courts. Status: Ongoing.
6.	<b>Public Outreach Campaign: Phase 2:</b> PAF's Language Access Subcommittee consulted with the NCSC and launched the public outreach campaign in March 2021. The outreach included three educational webinars, followed by direct outreach to courts and stakeholders. The campaign concluded with ethnic media runs that ran in August–October 2021, which provided placement of translated public service announcements, and infographics on "Do I Need a Court Interpreter" and "How to Work with a Court Interpreter," in newspapers and radio stations in the state's top 8 non-English spoken languages (Cantonese, Farsi, Korean, Mandarin, Russian, Spanish, Tagalog, and Vietnamese). Status: Completed.

7.	Annual Language Access Survey: As a follow-up to surveys conducted in 2016–2019, the Language Access Services Program sent out a language access survey to all 58 trial courts in September 2020 regarding courts' provision of language access services, as of June 30, 2020. A Language Access Metrics Report was issued in Fall 2021. Status: Completed.
8.	<b>Improving Access and Fairness through Technology:</b> PAF in collaboration with the Judicial Council's ITAC continued developing a Self-Represented Litigant E-Portal. Launched the Consumer Debt, Evictions, Small Claims, Civil Discovery, Domestic Violence, Fee Waivers, and Self-Represented Litigant resources to the Self-Represented Litigant Portal. ## Preparing for Your Remote Court Proceeding on Zoom – Quick Start Guide

#### 1. Choose Your Device

Device must have a video camera and microphone.

- Computer (desktop or laptop)
- Tablet
- Smartphone

Don't have one of these devices? Check with the court. You may have other options, like dialing into Zoom using a landline or mobile phone.

#### 2. *Recommended* — Download the Zoom Application

- Computer: Go to <u>zoom.us/download</u> and download Zoom Client for Meetings.
- Tablet or smartphone: Go to the App Store or Google Play and install the Zoom Cloud Meetings app.

Downloading Zoom gives you greater access to all its features, and it's free.

#### 3. Test Your Camera and Microphone

Go to <u>zoom.us/test</u> to join a test meeting. (This is just a test and no one else will be in the meeting.)

- Check that you can see yourself.
- Check that your microphone is working.
- Practice turning your microphone and camera off and on by selecting the icons.

A red slash through the microphone or camera icon means it is off. No red slash means it is on.

#### 4. Choose a Quiet Location

Choose somewhere that you can be at for some time without having to do other things. Do not choose a busy area of your home or a public location.

Make sure the background of the location you choose is appropriate for court.

- 5. Check Your Internet Connection or Phone Signal
  - Computer or tablet: Go to <u>www.speedtestnet</u>. Zoom requires a minimum speed of 1 Mbps (upload and download) for group video calling.
  - Smartphone: If using cellular data, be sure that you are in an area where you will have enough signal to connect without issues with your audio or video.

*Be sure to turn off other devices and applications that may be using the internet.* 

#### 6. Plan to Dress Appropriately

Even though you are not going to court in person, you must still dress appropriately. The clothing you choose should show respect for the court.

#### 7. Have Your Materials Ready

- Have all documents you might need ready for the proceeding.
- Have your Zoom meeting link or meeting ID and passcode ready.
- Have paper and a pen or pencil for taking notes.
- Charge your device and have a power cable nearby.

If you need to show a document as part of your court proceeding, check with the court to find out the best way to do this. The court may want you to send it by email in advance.

#### 8. Contact the Court If You Need Help

If you experience any technical difficulties, contact the court as soon as possible. Also contact the court ahead of time if you will need an interpreter for your court proceeding.

#### 1. Log Into Zoom

Select the Zoom meeting link you received from the court or enter it into a web browser. Enter the meeting ID and passcode if prompted. *Be sure to join a few minutes early.*



**Tips for Participating in Your Interpreted Proceeding** 

- 1. Listen and speak only in your language.
- 2. Speak slowly and pause often so the interpreter can interpret.
- 3. Address the judge as "Your Honor."
- 4. Tell the judge if you cannot hear or if you are having any technical difficulties.
- 5. Remain on camera at all times.
- 6. Do not interrupt.
- 7. Stay muted unless you are speaking.

#### [Select Your Device]

The first thing you'll need to do is select the device that you wish to use for your remote court proceeding. To join the remote proceeding, you will need a device for video and audio. This may be a computer (such as a laptop), tablet, or smartphone. The device must have a camera (so that others can see you) and microphone (so that others can hear you). It must also have access to the internet or cellular data.

If you do not have access to one of these devices, you may be able to dial into a remote court proceeding on Zoom using a landline or mobile phone. Notify the court if you need this option, particularly if you need interpretation.

#### [Download Zoom]

The next step is to download the Zoom application onto your device. This step is optional but recommended. You can still join Zoom without downloading and installing the application. But downloading and installing Zoom will allow you to use more of its features.

On a computer, go to <u>https://zoom.us/download</u> to get the most recent version of Zoom Client for Meetings. On your tablet or smartphone, go to the App Store or Google Play and install the Zoom Cloud Meetings app.

There is no cost to downloading Zoom on your device.

#### [Test Your Camera and Microphone]

Whether or not you download Zoom, you should test your camera and microphone before the proceeding. One way to do this is to join a test meeting. Just go to <u>https://zoom.us/test</u>. A Zoom test meeting is just a test and no one else will be in the meeting.

When joining a test meeting, be sure to follow the prompts to allow Zoom to access your microphone and camera. On a computer, you may need to select "Join with Video." You should see yourself on the screen. This tells you that your camera is working.

If this is your first time using Zoom on your device, Zoom may automatically run a test to confirm that your sound is working. You can also select the small "up arrow" icon next to the microphone icon on the toolbar at the bottom of the screen. On the menu that appears, select "Test Speaker & Microphone." You will hear sounds and be prompted to say something to verify that you can hear and be heard.

Next to the microphone icon, you will see a camera icon. When there is a red slash through either icon, that means they are off. If there is no red slash through them, they are on. For your court proceeding, make sure that your camera is on and that your microphone is off (muted) until it is your turn to speak. Practice turning your microphone and camera off and on by selecting or tapping these icons.

#### [Choose a Quiet Location]

You should plan to join your remote court proceeding from a quiet location. Choose somewhere that you can be at for some time without having to do other things, like work or drive. Do not choose a busy area of your home or a public location. Remember you will be on camera during the proceedings, so make sure the background of the location you choose will be appropriate for court.

#### [Check Your Internet Connection or Phone Signal]

You will need a strong internet connection to use Zoom for your remote court proceeding. Check that you can connect to the internet in the location you choose. If you are connecting using cellular data, be sure that you are in an area where you will have enough signal to connect to the meeting without issues with your audio and video. Also, be sure to turn off other devices and applications that may be using the internet at the same time as your court proceeding.

#### [Plan to Dress Appropriately]

About ten minutes before your scheduled court proceeding, go ahead and join the meeting by selecting the Zoom meeting link or entering it into a web browser. Or, if you downloaded the Zoom application, open it on your device. Then, enter the meeting ID and the meeting passcode, if required. You can find this information in the invitation you received from the court.

Keep in mind, if using the Zoom application, be sure that you have downloaded the latest updates, particularly if you have previously installed the application onto your device.

If you're using a computer and you did not download the Zoom application, you can go to <u>https://zoom.us/join</u> on any web browser. Enter the meeting ID and select "Join." Zoom will ask

you if you would like to download the application or join via a web browser. Select "Join from Your Browser."

You may also be prompted to enter your name when joining, particularly if you have not connected to Zoom on your device before. Be sure to enter your full name and that it does not show up as "iPhone," your phone number, or another family member's name. This will help the court identify you.

Zoom will also prompt you to connect to audio and video. Be sure to allow access to your camera and select "Join with Video" if prompted. If asked how you want to join audio, select your device's audio or connect over Wi-Fi. On a phone or tablet, you may also connect using cellular data if you prefer. (Data rates apply.) If your device does not have a microphone, you can use a telephone for audio. Refer to the meeting invitation and call one of the phone numbers listed. Follow the prompts to enter your meeting ID and passcode, if required. Again, notify the court if you will be dialing in, especially if you need an interpreter.

When you join, you may need to wait until the court starts the meeting or lets you into the meeting. If this happens, you will see a notification to wait until the host lets you in. If there are other cases before yours, you may have to wait for some time until your case is called.

When the court lets you in, you will see the other participants on screen. Make sure you can see them clearly, and that they can see you. On a computer, you may need to select "Gallery View" from the "View" menu to see all participants. Selecting "Speaker View" will only show the person speaking. On a smartphone or tablet, you may have to swipe to see other participants.

Sit directly in front of your camera so that you are in full view. Make sure your microphone is muted, with a red slash over the microphone icon.

Note that the court may have certain settings selected that control what you can see and do. For example, the court may have the gallery view disabled. It may also have all participants' microphones set to mute. If so, you will get a message prompting you to unmute when it is your turn to speak.

#### [Joining Interpretation]

If you have asked for an interpreter for your court proceeding, you must select a language channel when you join the meeting. On a computer, select the globe icon on the toolbar. Then select the language you wish to speak in and hear. On a tablet or smartphone, select the "More," or three dots, icon. Select "Language Interpretation" from the menu that appears, and then select your

language. Be sure to select "Done" to confirm your selection and be placed into your language channel.

Once in your language channel, you will hear the interpreter speaking. You will also hear the English-speaking parties at a very low volume. If you do not want to hear the English-speaking parties, select "Mute original audio" from the language interpretation menu.

#### [Participating in the Remote Proceeding]

Throughout the proceeding, do not interrupt the judge or others as they are speaking. But *do* let the judge know if you have questions or technical difficulties. On Zoom, you can do this by using the "raise hand" icon, which you can get to by selecting the "reactions" icon on a computer or the three dots ("more" menu) on a smartphone. Using this will place a small hand next to your name and over your video, signaling to the judge and other participants that you have a question or a problem.

At the end of your court proceeding, the court may end the meeting or will tell you that you can leave. Select the red "Leave Meeting" button to exit the meeting.

# Rule 1.300 Review

## Rule 1.300 Overview

- Effective September 1, 2019, the Judicial Council of California adopted Rule
   1.300 into the California Rules of Court.
- Rule 1.300 states, "As soon as feasible, each court must adopt procedures to enable limited English proficient court litigants to access court-ordered and court-provided programs, services, and professionals to the same extent as persons who are proficient in English."
- The rule also provides practical guidance to courts on improving access to court-ordered programs and services.

## **Project Overview**

**Project Goal:** To identify possible strategies for the successful statewide implementation of Rule 1.300

### **Project Tasks:**

- Rule 1.300 questions included in 2020 statewide language access survey
- Telephone interviews conducted with Language Access Representatives from a range of courts



## Challenges and Successes

## Challenges

- Over 200 languages spoken in California
- Court-ordered services provided in a wide range of settings (including directly by the court and in private settings outside of the courthouse)
- Few services available in many areas

## Successes

- Several courts have developed policies to ensure language access to court-ordered and court-provided services
- California courts embrace technology to provide language access (SHARP)







- Courts use various mechanisms for providing direct language services for many court-ordered programs and services conducted and provided by the court.
- Language services include in-person interpretation, remote interpretation, bilingual staff assistance, and translated forms and other materials.







- Courts also have processes in place to support court users in identifying linguistically accessible programs.
- Examples include compiled lists of services, posted flyers, online information, and community outreach efforts.









- Some courts noted using technology to leverage resources for linguistically accessible programs.
- Examples include resource sharing with other courts and providing prerecorded trainings and workshops in a language other than English.





## Findings

- Courts expressed interest in:
  - A centralized statewide list of linguistically available programs
  - Peer-to-peer communication support (i.e., a listserv or ongoing meetings)
  - Outreach to service providers to educate them on language needs
  - Outreach to justice partners on Rule 1.300
  - Exploration of technology to leverage resources/share linguistically available programs



## Considerations

- The Judicial Council and the courts may consider:
  - Continued expansion of technology to assist with the virtual delivery of linguistically accessible programs statewide
  - Multilingual videos and online modules for court-ordered program content to be shared statewide
  - A centralized database or repository of linguistically accessible programs made available on an intranet for court use



## Considerations (continued)

- Statewide guidance on identifying, vetting, and compiling linguistically accessible program options at the local level
- Facilitated information sharing (i.e., through listserv, roundtable discussions, meetings, etc.)
- Materials to inform service providers and justice partners on Rule 1.300



## Timeline

- April 2022: NCSC to present research on court usage of and availability of LEP services for subcommittee background and context
- Spring/Summer 2022: Judicial Council staff will work with the subcommittee to develop a project plan with select strategies
- Summer/Fall 2022: Staff to present project plan to PAF for consideration
