Item 1

Language Access Signage and Technology Grant Program, Cycle 5 (Action Required)

Presenter: Hon. Victor A. Rodriguez, Associate Justice of the Court of Appeal, First Appellate District, Division Three and Co-chair of the Advisory Committee on Providing Access and Fairness

Justice Victor Rodriguez provided committee members with a brief update on Cycle 5 of the Language Access Signage and Technology Grant Program for Fiscal Year 2023-24. Full details of the grant program report can be found in the meeting materials.
