The following new projects are under consideration or have been recommended for inclusion in the Annual Agenda for 2016:

- 1. New proposal from Spectrum Institute for rules of court and Standards of Judicial Administration concerning qualifications, continuing education requirements, and performance standards for court-appointed counsel in limited conservatorships;
- 2. Continuation of Rules Modernization Project beyond rule 7.802 to include changes in the rest of the Probate Code;
- 3. Expanded use of expedited trials/procedures (Survey Comments for SRL subgroup);
- 4. Judicial Council form for court confirmation of a Trustee's sale of real property (Attorney Danielle E. Miller);
- 5. Changes to Petition for Probate (form DE-111), from Tom Johnson, Managing Probate Attorney, Superior Court of Riverside County:
  - Add a statement indicating whether the decedent was a citizen of a foreign county, trigger notice to a consulate, per sec. 8113;
  - A way to designate that the proposed will is a lost will, which would notify the affected parties of the presumption under sec. 6124; and,
  - A way to designate that appointment is sought as a successor personal representative, similar to the designation of successor conservator in GC-310;
- 6. Legislation to remove Probate Code section 9000(a)(3) (Tom Johnson).

"This little-known technicality is counter-intuitive, and serves as a procedural trap for the unwary personal representative. It seems logical that funeral expenses would be expenses of administration. Funeral expenses are almost universally advanced by the personal representative or some other family member, and reimbursement is requested in the petition for final distribution. It seems unjust that parties could successfully object to reimbursement of funeral expenses merely because the formality of a creditor claim was not observed."

- Proposal to amend Probate Code section 10953 to permit awards of fees to Public Administrators and counsel for services they render in response to a court order under Probate Code section 7600 et seq. due to failure of the personal representative to account even if the PA is not appointed as personal representative (Tom Johnson);
- 8. Revision of the Capacity Declaration—Conservatorship (form GC-335);
- 9. Revision of *Petition to Determine Succession to Real Property* (form DE-310) to require statement of character of property as community, separate, or quasi-community (Christine Donovan, Senior Staff Research Attorney, Family Law and Probate Divisions, Superior Court, of Solano County).
