

	Someone age 18 or older— <b>not you or anyone else protected by the restraining order</b> —must personally serve (give) a copy of the following forms on the respondent at least days before the hearing.
	• SV-700, Request to Renew Restraining Order;
	• SV-710, Notice of Hearing to Renew Restraining Order (this form);
	• SV-720, Response to Request to Renew Restraining Order (blank copy);
	• SV-130, the current <i>Private Postsecondary School Violence Restraining Order After Hearing</i> for which renewal is requested.
	After the respondent has been served, file Form SV-200, <i>Proof of Personal Service</i> , with the court clerk. For help with service, read Form SV-200-INFO, <i>What Is "Proof of Personal Service"?</i>
