A.M. appeals orders entered at a jurisdiction and disposition hearing held pursuant to Welfare and Institutions Code sections 300 and 360 et seq. Citing *In re Sade C.* (1996) 13 Cal.4th 952, she asks this court to exercise its discretion to review the record for error.

In *In re Sade C.*, the California Supreme Court held that review pursuant to *People v. Wende* (1979) 25 Cal.3d 436 is unavailable in "an indigent parent's appeal from a judgment or order, obtained by the state, adversely affecting [her] custody of a child or [her] status as the child's parent." (*In re Sade C.*, *supra*, 13 Cal.4th at p. 959.) We therefore deny A.M.'s requests to review the record for error and address her *Anders* issue. (*Anders v. California* (1967) 386 U.S. 738.)

Citing *In re Phoenix H.* (2009) 47 Cal.4th 835, A.M.'s counsel requests leave for their client to file a supplemental brief in propria persona. Counsel also asks this court to order counsel to brief any arguable issue. (*Penson v. Ohio* (1988) 488 U.S. 75, 88.) The requests are denied.

DISPOSITION

The appeal is dismissed.
