Budget and Program Priorities for FY 2014-15

Increase access to the public, restore services and create efficiencies through technology. Currently, staff must turn away approximately 20 clients per day from Self-Help. Court Investigators are behind in their review of reports. With the increase in backlogs in the Civil Law & Motion and Traffic calendars, parties wait up to 4 months for a hearing.

Self-Help / Mediation / Facilitator Services

- Reduced office hours of Solano Legal Access Center and Family Law Facilitator offices.
- Restraining orders are the only matter handled on Fridays.
- Court is closed for walk-ins on Wednesdays; clients seen that day by appointment only.
- Reduced self-help services at the Vallejo courthouse.

Court Reporters / Investigator Services

- Eliminated court reporters from misdemeanor cases in FY 2011-12.
- Court Investigators have substantial backlog of review reports for conservatorship cases.

Counters / Clerks / Telephones

- Reduced clerk's office hours by one hour per day in FY 2011-12.
- Reduced hours by another hour effective 1/14/13.
- Unable to restore clerk's office hours with current proposed allocation.

Staff Impacts / Furloughs / Layoffs / Unfilled Vacancies

- Laid off three regular positions in FY 2011-12.
- Instituted furloughs in FY 2009-10 and FY 2012-13.
- Current vacancy rate strains remaining staff.

Budget Challenges for FY 2014-15

Staffing shortages have created significant backlogs in Civil, Family Law, Traffic and the Court Investigators Office. Closing clerks' offices early limits access for the public and increases errors and inefficiencies with case flow processing due to reduced staffing. Self Help Center must continue to turn people away on a daily basis.
