The Judicial Council respectfully submits this report, required under Government Code section 70352, on fiscal year (FY) 2006–2007 Court Facilities Trust Fund expenditures.

Money deposited in the Court Facilities Trust Fund, under County Facility Payment agreements, provides for the maintenance and operation of court facilities that transfer to state responsibility.

In FY 2006–2007, \$2,489,173 was expended from the Court Facilities Trust Fund for operation and maintenance costs for fifty-one (51) court facilities that transferred to state responsibility as of June 30, 2007:


